#### **ORDINANCE NO. 08, s. 2021**

AN APPROPRIATION ORDINANCE APPROVING THE GENERAL FUND CY 2021 SUPPLEMENTAL BUDGET NO. 2 OF THE RIZAL PROVINCIAL GOVERNMENT AMOUNTING TO ONE BILLION TWO HUNDRED FIFTY FOUR MILLION FOUR HUNDRED TWENTY SIX THOUSAND TWO HUNDRED TWENTY EIGHT PESOS AND 48/100 (PHP1,254,426,228.48)

#### Be it Enacted by the Sangguniang Panlalawigan of Rizal in Session Assembled:

**SECTION 1.** The General Fund CY 2021 Supplemental Budget No. 2 amounting to One Billion Two Hundred Fifty Four Million Four Hundred Twenty Six Thousand Two Hundred Twenty Eight Pesos and 48/100 (Php1,254,426,228.48) of the Rizal Provincial Government is hereby approved, to wit:

**SECTION 2.** That the appropriation for Infrastructure projects in the total amount of PhP1,250,000,000.00 is necessary to effectively address the growing medical needs and other health concerns of our citizenry under the new normal including the attainment of the long desired vision of the province to have a medical school run by the Provincial Government, which are geared towards a much higher level of socioeconomic development;

**SECTION 3**. That the additional appropriation for the Repair and Maintenance of RPHS buildings in the amount of PhP2,142,238.22 shall be used for termite treatment and repair of dietary rooms;

**SECTION 4**. That the appropriation for Other Personnel Benefits under various offices shall be intended for the grant of Loyalty Award and Monetization of Leave Credits in the amount of PhP395,000.00 and PhP647,279.77, respectively;

**SECTION 5.** That the Interspecial Account Transfer from General Fund - Proper to Hospital (RPHS) in the amount of Eight Hundred Thousand Pesos (PhP800,000.00) is hereby authorized;

**SECTION 6.** That the Provincial Governor and the Vice Governor are hereby authorized to augment any item of their respective appropriations in this Ordinance from savings in other items within the same expense class;

**SECTION 7.** That the Provincial Governor, Hon. Rebecca A. Ynares, is hereby authorized to enter into any contract/agreement relative to the implementation of this budget and its undertakings and that the same is hereby confirmed and ratified; and

**SECTION 8**. All existing accounting, auditing rules and regulations pertaining to disbursement of funds shall be observed accordingly.

**SECTION 9.** This Ordinance shall take effect upon its approval.
