AN APPROPRIATION ORDINANCE APPROVING THE GENERAL FUND CY 2022 SUPPLEMENTAL BUDGET NO. 3 OF THE RIZAL PROVINCIAL GOVERNMENT AMOUNTING TO TWO HUNDRED THIRTY NINE MILLION FOUR HUNDRED SEVENTY THREE THOUSAND THREE HUNDRED ONE PESOS AND 10/100 (PHP239,473,301.10)

Be it Enacted by the Sangguniang Panlalawigan of Rizal in Session Assembled :

SECTION 1. The General Fund CY 2022 Supplemental Budget No. 3 amounting to Two Hundred Thirty Nine Million Four Hundred Seventy Three Thousand Three Hundred One Pesos and 10/100 (Php239,473,301.10) of the Rizal Provincial Government is hereby approved, to wit:

SECTION 2. That the appropriation for infrastructure projects under "Annex A" geared towards promotion, enhancement and attainment of social and economic growth of the Province in the total amount of PhP236,193,480.12 is hereto attached and made an integral part of this Ordinance;

SECTION 3. That the additional fund for Personal Services under the Office of the Provincial Veterinarian have been provided in the total amount of PhP441,253.18 for the creation of position pursuant to Sangguniang Panlalawigan Ordinance No. 39, s. 2021 dated 15 November 2021;

SECTION 4. That the additional appropriation for Fuel, Oil and Lubricant Expenses under various offices in the total amount of PhP1,396,273.10 is needed due to oil price hike;

SECTION 5. That the additional appropriation for Electricity Expenses have been provided for the Isolation Facility of the Provincial Health Office in the total amount of PhP1,371,617,.25;

SECTION 6. That the appropriation for Terminal Leave Benefits in the amount of PhP60,677.45 shall be disbursed in accordance with the pertinent laws, rules and regulations;

SECTION 7. That the payment of Outstanding Obligation for Personal Services under Rizal Provincial Hospital System in the amount of PhP10,000.00 shall be made within this calendar year;

SECTION 8. That the Provincial Governor and the Vice Governor are hereby authorized to augment any item of their respective appropriations in this Ordinance from savings in other items within the same expense class;

SECTION 9. That the Provincial Governor is hereby authorized to enter into any contract/agreement relative to the implementation of this budget and its undertakings and that the same is hereby confirmed and ratified;

SECTION 10. All existing accounting and auditing rules and regulations pertaining to disbursement of funds shall be observed accordingly; and

SECTION 11. This Ordinance shall take effect upon its approval.
