AN APPROPRIATION ORDINANCE APPROVING THE GENERAL FUND CY 2022 SUPPLEMENTAL BUDGET NO. 5 OF THE RIZAL PROVINCIAL GOVERNMENT AMOUNTING TO TWENTY TWO MILLION EIGHT HUNDRED SEVENTY ONE THOUSAND THREE HUNDRED NINETEEN PESOS AND 80/100 (PHP22,871,319.80)

- **SECTION 2**. That the amount of PhP985,803.55 is for the Additional Works for the Construction of Retaining Wall (Slope Protection) at the Provincial Satellite Auditing Office (PSAO) Rizal at Sitio Cabading, Brgy. Inarawan, Antipolo City;
- **SECTION 3**. That the additional funds for Drugs and Medicines Expenses and Medical, Dental and Laboratory Supplies Expenses in the amount of PhP3,100,000.00 and PhP10,305,900.00, respectively, are intended for the vaccination program and orthopedic services of RPHS Margarito A. Duavit Memorial Hospital and Casimiro A. Ynares, Sr. Memorial Hospital;
- **SECTION 4**. That the provided amount for land PhP7,760,000.00, and building, PhP680,000.00, are intended for the expropriation of properties located adjacent to RPHS-Casimiro A. Ynares, Sr. Memorial Hospital needed for its expansion;
- **SECTION 5**. That the appropriation for Terminal Leave Benefits in the amount of PhP39,616.25 shall be disbursed in accordance with the pertinent laws, rules and regulations;
- **SECTION 6.** That the Provincial Governor is hereby authorized to augment any item of appropriations in this Ordinance from savings in other items within the same expense class;
- **SECTION 7.** That the Provincial Governor is hereby authorized to enter into any contract/agreement relative to the implementation of this budget and its undertakings and that the same is hereby confirmed and ratified;
- **SECTION 8**. All existing accounting and auditing rules and regulations pertaining to disbursement of funds shall be observed accordingly; and
 - **SECTION 9.** This Ordinance shall take effect upon its approval.
