SECTION 2. That the appropriation for infrastructure projects in the total intended to service the needs of the residents of theprovince pursuant ro Section 17 (b)(3)vii) of Republic Act (R.A) No. 7160 and in accordance with Executive Order No. 138 dated June 1, 2021 in the total of amount PhP287,260,000.00, which include the amount of PhP44,6000,000.00 for development projects funded out of no less than twenty percent (20%) of the additional National Tax Allotment and PhP13,830,000.00 for Local Disaster Risk Reduction and Management Fund in compliance with Section 287 of R.A. No. 7160 and R.A. No. 10121, respectively, are geared towards promotion, enhancement and attainment of social and economic growth of the Province;

SECTION 3. That additional funds for Personal Services in the total amount of PhP42,702,023.04 has been provided for the implementation of the Third Tranche of the Modified Salary Schedule pursuant to Republic Act No. 11466 effective January 1, 2022 in accordance with Local Budget Circular No. 143 dated January 3, 2022 by the Department of Budget and Management (DBM);

SECTION 4. That the appropriation for additional fund for Electricity Expenses and Drugs and Medicines Expenses of Rizal Provincial Hospital System(RPHS) in the amount of PhP5,000,000.00 and Php20,000,000.00, respectively;

SECTION 5. That the appropriation for additional fund for Donations under Provincial Social Welfare and Development Office in the total amount of PhP15,750,000.00 wherein PhP2,750,000.00 is intended for the protection of childred program in accordance with R.A No. 7610, PhP1,000,000.00 for person with disabilities welfare program pursuant to R.A. No. 9442 amending R.A. 7277 and PhP1,750,000.00 for senior citizen welfare program pursuant to R.A. No. 9994 amending R.A. No. 7432;

SECTION 6. That the appropriation for Terminal Leave Benefits in the amount of PhP267,077.47 shall be disbursed in accordance with the pertinent laws, rules and regulations; and

SECTION 7. That the payment of Outstanding Obligation for Personal Services under Provincial Governor's Office in the amount of PhP7,300.48 total amount of Php46,756.08 and Php4,285.58, respectively shall be made within this calendar year;

SECTION 8. That the Provincial Governor and the Vice Governor are hereby authorized to augment any item of their respective appropriations in this Ordinance from savings in other items within the same expense class;

SECTION 9. That the Provincial Governor is hereby authorized to enter into any contract/agreement relative to the implementation of this budget and its undertakings and that the same is hereby confirmed and ratified;

SECTION 10. All existing accounting and auditing rules and regulations pertaining to disbursement of funds shall be observed accordingly; and

SECTION 11. This Ordinance shall take effect upon its approval.
