SECTION 3. That the Provincial Governor is hereby authorized to augment any item of the appropriations in this Ordinance from savings in other items within the same expense class;

SECTION 4. That the Provincial Governor is hereby authorized to enter into any contract/agreement relative to the implementation of this budget and its undertakings and that the same is hereby confirmed and ratified; and

SECTION 5. All existing accounting, auditing rules and regulations pertaining to disbursement of funds shall be observed accordingly.

SECTION 6. This Ordinance shall take effect upon its approval.
