AN APPROPRIATION ORDINANCE APPROVING THE GENERAL FUND CY 2020 SUPPLEMENTAL BUDGET NO. 5 OF THE RIZAL PROVINCIAL GOVERNMENT AMOUNTING TO SIX HUNDRED MILLION FOUR HUNDRED FOURTEEN THOUSAND EIGHT HUNDRED THIRTY SEVEN PESOS AND 20/100 (PhP 600,414,837.20)

SECTION 6. All existing accounting, auditing rules and regulations pertaining to disbursement of funds shall be observed accordingly.

SECTION 7. This Ordinance shall take effect upon its approval.
