Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from the Procurement Division, Rizal Provincial Government and inspect the Bidding Documents at the address given below during **Office Hours (8 am – 4 pm)**.

A complete set of Bidding Documents may be purchased by any interested Bidders on **June 29, 2017** – **July 18, 2017** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **P 5,000.00**.

The Rizal Provincial Government will hold a Pre-Bid Conference on July 6, 2017 at 11:00 am, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before **July 19, 2017 until 1:00 pm**. All Bids must be accompanied by a bid security in the amount equal to the percentage of the Approved Budget for the Contract in accordance with the form of bid security prescribed herein.

Bid opening shall be on **July 19, 2017** at **3:00 pm**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Rizal Provincial Government reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
