## **INVITATION TO BID**

## SUPPLY OF FUEL THROUGH FLEET CARD FACILITY

The Rizal Provincial Government, through the **General Fund** intends to apply the sum of Thirteen Million Three Hundred Eighteen Thousand Eight Hundred Seventy-Nine Pesos and Ninety-Four Centavos (**PhP13,318,879.94**) being the Approved Budget for the Contract (ABC) for payments under the contract for **Supply of Fuel through Fleet Card Facility**.

The Rizal Provincial Government now invites bids for the **Supply of Fuel though Fleet Card Facility.** Contract duration is **until December 31, 2021**. Bidders MUST have a completed contract similar to the Project for at least **3 years** prior the date of submission and receipt of bids. The completed contract must be at least 50% of the ABC for non-expendable supplies, and 25% of the ABC for expendable supplies.

Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (R.A. 9184), otherwise known as the Government Procurement Reform Act.

The Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to R.A. No. 5183 and subject to Commonwealth Act 138.

All particulars relative to Pre-Bid Conference, Eligibility Statement and Screening, Bid Security, Performance Security, Evaluation of Bids, Post Qualification, Award of the Contract, and Notice to Proceed shall be governed by the pertinent provisions of Republic Act No. 9184 (R.A. 9184) otherwise known as Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations.
