**RESOLUTION POSTPONING THE PUBLIC BIDDING OF THE PROVINCIAL
INFRASTRUCTURE PROJECTS SCHEDULED ON 26 AUGUST 2025 AND
MOVING THE DEADLINE OF SUBMISSION OF BIDS AND OPENING OF
BIDS TO 27 AUGUST 2025 OR THE NEXT WORKING DAY IF THERE WILL
BE WORK SUSPENSION**

WHEREAS, the Rizal Provincial Government, through the Rizal Provincial Bids and Awards Committee (RPBAC), advertised an Invitation to Bid (ITB) for the procurement of provincial infrastructure projects from the period of 7 August to 13 August 2025;

WHEREAS, the publication covers thirty-two (32) provincial infrastructure projects with schedule of bid opening/public bidding on 26 August 2025;

WHEREAS, in the Invitation to Bid (ITB) for the said public bidding, deadline of submission of bids was set at eleven o'clock in the morning (11:00 a.m.) on 26 August 2025;


WHEREAS, due to the inclement weather and as per Memorandum Circular No. 94-A issued by the Office of the President on 25 August 2025 suspending work in government offices and classes at all levels in Metro Manila and several provinces including the Province of Rizal, the Rizal Provincial Government, through the Rizal Provincial Bids and Awards Committee (RPBAC) resolved to move the deadline of submission of bids and postpone the public bidding of the aforementioned infrastructure projects and move the deadline of submission of bids and opening of bids from 26 August 2025 to 27 August 2025, same time;

NOW THEREFORE, WE, the members of the Rizal Provincial Bids and Awards Committee (RPBAC) for and in consideration of the foregoing, hereby resolved, as it is hereby RESOLVED, to move the deadline of submission of bids and postpone the public bidding of the aforementioned provincial infrastructure projects scheduled on 26 August 2025 and move the deadline of submission of bids and opening of bids to 27 August 2025, same time, or the next working day, same time, if there will be work suspension on the said date.


RESOLVED FURTHER, that copies of this Resolution be furnished to the Philippine Government Electronic Procurement System (PhilGEPS), and to the State Auditor, Commission on Audit (COA) of this Province, and be published at the Province of Rizal website and bulletin board.
