THE LOWEST AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL****Resolution No. 002

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the contract of Treatment and Transport of Hazardous Waste for the Rizal Provincial Hospital System which was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol Building, Rizal Provincial Hospital-Morong Main and Ynares Sports Center for the period covered 03 December 2020 to 21 December 2020, in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;

WHEREAS, the Approved Budget for the Contract (ABC)/Certificate of Availability of Funds as stated in the ITB is ₱4,550,000.00 or ₱ 32.00 per kilo;

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid, that is, Cleanhaul Environmental Services, Inc. and Servo-Treat Philippines, Inc.;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 22 December 2020 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid were found to be substantially complying;

WHEREAS, the detailed evaluation of the bids conducted after the opening of bids resulted in the following:

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Cleanhaul Environmental Services, Inc. appears to be the lowest calculated bid for the contract of treatment and transport of hazardous waste for the Rizal Provincial Hospital System in the amount of ₱ 23.95 per kilo or an aggregate amount which, in no case, shall exceed the ABC;

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bids submitted by the bidders, all of the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;
