

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF
THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING
APPROVAL**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of one (1) unit 10 Wheeler Towing Truck and two (2) units 10 Wheeler Wing Van Truck which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website, and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Ynares Center Complex and Ynares Sports Arena for the period covered 28 July 2021 to 16 August 2021, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P28,100,000.00;

WHEREAS, in response to the said advertisement, only one (1) bidder/supplier purchased bid documents and submitted its bid;

WHEREAS, the bidder's technical and eligibility documents were submitted on 17 August 2021 where bidder was thereafter found to be eligible;

WHEREAS, the bid proposal of the bidder was found to be substantially complying;

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that BSA 99 Enterprises Incorporated appears to be the single calculated bid for the purchase of one (1) unit 10 Wheeler Towing Truck and two (2) units 10 Wheeler Wing Van Truck in the total amount of P 28,000,000.00;

WHEREAS, upon careful examination, validation and verification of the eligibility requirements technical and financial component of the bid submitted by the bidder, documents passed the post-qualification and such has been found to be responsive;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

1. **TO DECLARE BSA 99 ENTERPRISES INCORPORATED** as the bidder with the single calculated and responsive bid for the purchase of one (1) unit 10 Wheeler Towing Truck and two (2) units 10 Wheeler Wing Van Truck in the total amount of ₱ 28,000,000.00;
2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
