

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE LOWEST CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2021-088
Series of 2021**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Laboratory Supplies which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: Rizal Provincial Government Capitol, Ynares Center Complex and Ynares Sports Arena for the period covered 19 August 2021 to 8 September 2021 in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P3,891,365.00;

WHEREAS, in response to the said advertisement, five (5) suppliers/contractors purchased bid documents and submitted its bid;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted 9 September 2021 and thereafter found to be eligible;

WHEREAS, the other bidder's financial component of the bid was found to be substantially complying;

WHEREAS, when the submitted bids were read, it appears that **Medical Center Trading Corporation** submitted quotation for Item Nos. 1-2, 4-6, 8-11, 14, 15, 17-20, 25, 26, 29, 30-32, 34, 36 and 41, in the amount of P2,281,024.00, **Scientific Biotech Specialties, Inc.** submitted quotation for Item Nos. 33 and 34 in the amount of P1,710,964.00, **Medalert Enterprises** submitted quotation for Item Nos. 2, 4, 6-8, 10-12, 14, 20, 21, 23, 24, 26, 27, 35 and 45 in the amount of P 1,347,294.70, **Nemrac Medical and Pharma Supplies Corporation** submitted quotation for Item Nos. 1, 2, 4, 5, 7, 9, 10, 11, 13-15, 18-21, 23, 26, 29, 30-32, 35, 36, 41, and 45-47 in the amount of P 1,065,334.00 and **Allied Hospital Supply International Corporation** submitted quotation for Item Nos. 5 and 6 in the amount of P 438,400.00;

WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, when the submitted bids were evaluated, **Medalert Enterprises** quotation for Item Nos. 12, 24, 27 and 35 in the amount of P 83,849.80, **Nemrac Medical and Pharma Supplies Corporation** quotation for Item Nos. 2, 4, 7, 11, 13-15, 21, 23, 26, 29 and 45-47 in the amount of P 304,372.00, **Allied Hospital Supply International Corporation's** quotation for Item Nos. 5 and 6 in the amount of P438,400.00, **Medical Center Trading Corp.'s** quotation for Item Nos. 1, 8, 9, 10, 17-20, 25, 30-32, 36 and 41 in the amount of P 616,210.00 and **Scientific Biotech Specialties, Inc.** quotation for Item Nos. 33 and 34 in the amount of P 1,710,964.00; and appears to be the lowest calculated bid per item submitted of each bidder (Bid Evaluation is hereto attached for ready reference);

WHEREAS, in the quotation submitted by the bidders, **no bid** was received on **Item Nos. 3, 16, 22, 28, 37, 38, 39, 40 and 42-44** (11 line item) in the total amount of P 73,475.00;

WHEREAS, the technical and financial components including the eligibility requirements of the bid submitted by the bidders were carefully examined, validated and verified. However, it was found out that **Medical Center Trading Corporation** and **Nemrac Medical and Pharma Supplies** have the same bid offer for Item No. 10. The Bids and Awards Committee resolved the tie of the bidders thru

"Toss Coin" as provided under the law (see Appendix 11 GPPB Circular 06-2005) and thru which Medical Center Trading Corporation came as the winner;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** the following, and:

1. TO DECLARE:


- 1.1 **MEDALERT ENTERPRISES'** quotation for Item Nos. 12, 24, 27 and 35 in the amount of **P83,849.80**;
- 1.2 **NEMRAC MEDICAL AND PHARMA SUPPLIES CORPORATION's** quotation for Item Nos. 2, 4, 7, 11, 13-15, 21, 23, 26, 29 and 45-47 in the amount of **P 304,372.00**;
- 1.3 **ALLIED HOSPITAL SUPPLY INTERNATIONAL CORP.'s** quotation for Item Nos. 5 and 6 in the amount of **P 438,400.00**;
- 1.4 **MEDICAL CENTER TRADING CORPORATION's** quotation for Item Nos. 1, 8, 9, 10, 17-20, 25, 30-32, 36 and 41 in the amount of **P616,210.00**; and
- 1.5 **SCIENTIFIC BIOTECH SPECIALTIES, INC.** quotation for Item Nos. 33 and 34 in the amount of **P 1,710,964.00**;

as the lowest calculated and responsive bid for the supply and delivery of such laboratory supplies.

- 2. That **NO BID** was received for Item Nos. 3, 16, 22, 28, 37, 38, 39, 40 and 42-44 (11 line item) amounting to **P 73,475.00**, has been referred to the BAC members and thereafter decided to re-advertised and re-bid the said items, pursuant to the provisions of RA 9184.
- 3. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
