

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE
DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID
AND ITS RECOMMENDING APPROVAL**

**Resolution No. GS2022 - 100
Series of 2022**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Medical Supplies for use in Peritoneal Dialysis at RPHS Margarito A. Duavit Memorial Hospital which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS-Angono and RPHS-Morong for the period covered 9 September 2022 to 28 September 2022, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱7,649,400.00;

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 29 September 2022 and thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.







2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.




