

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE LOWEST CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**Resolution No. GS2022- 088
Series of 2022**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Medical Supplies which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, RPHS - Angono and RPHS - Morong for the period covered 4 August 2022 to 23 August 2022, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱20,816,325.00;

WHEREAS, in response to the said advertisement, eight (8) suppliers/contractors purchased bid documents and submitted its bid;

WHEREAS, the opening of bids was originally scheduled on 24 August 2022. However, due to inclement weather caused by Severe Tropical Storm "Florita" and as per declaration of work suspension by the President, Ferdinand Marcos, Jr. in the affected area including the Province of Rizal, the opening of bids was scheduled on the next working day which is on 25 August 2022;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 25 August 2022 and thereafter found to be eligible;

WHEREAS, the other bidder's financial component of the bid was found to be substantially complying;

WHEREAS, when the submitted bids were read, it appears that, **Nemrac Medical & Pharma Supplies Corporation** submitted quotation for Item Nos. 1-36, 38-55, 57-73, and 76-78 in the amount of ₱ 20,080,921.75, **Patient Care Corporation** submitted quotation for Item Nos. 1-12, 15-36, 38-50, 51-55, 57-63, and 65-78 in the bid amount of ₱ 19,053,847.75, **JCOR Medical Equipment Supplies Trading** submitted quotation for Item Nos. 1-32, 38-55, and 57-78 in the bid amount of ₱ 16,738,534.25, **Medalert Enterprises** submitted quotation for Item Nos. 1- 6, 11-32, 38-43, 47-49, 54, 55, 57-58, 60-73 and 77-78 in the bid amount of ₱ 14,061,237.50, **Medical Center Trading Corporation** submitted quotation for Item Nos. 4-6, 15-18, 23-27, 33-37, 39-41, 47, 48, and 66-70 in the bid amount of ₱ 9,696,042.00, **Blu Enterprises** submitted quotation for Item Nos. 3-6, 11, 12, 15-19, 21-28, 38-43, 47, 48, 55, 58, 60-62, 64, 65 and 77 in the bid amount of ₱ 9,174,482.00, **Rite-Tech Marketing** submitted quotation for Item Nos. 7-10, 17, 18, 44-46, 50-53 and 55 in the bid amount of ₱ 2,262,555.00, and **Luzon Quick-Serve Trading Corporation** submitted quotation for Item Nos. 11-12, 17-18, 20-27, 32, 42 and 43 in the bid amount of ₱ 1,687,390.00;

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid;

WHEREAS, in the quotation submitted by the bidders, **no bid** was received on **Item No. 56** in the amount of ₱ 3,800.00;

WHEREAS, when the submitted bids were evaluated, **Patient Care Corporation** submitted quotation for Item Nos. 33, 60, 72 and 73 in the amount of ₱ 1,533,675.00, **Luzon Quick-Serve** submitted quotation for Item Nos. 11, 12, 17, 18, 20-27, 32, 42 and 43 in the

3. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


