**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Laboratory and Radiology supplies which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Rizal Provincial Hospital-Morong Main and Ynares Sports Arena for the period covered 16 February 2022 to 07 March 2022, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is P12,077,025.00;

**WHEREAS**, in response to the said advertisement, five (5) supplier/contractor purchased bid documents and submitted its bid;

**WHEREAS**, the bidders' technical component of the bid, including the eligibility requirements were submitted on 08 March 2022 and thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**WHEREAS**, when the submitted bids were read, it appears that, **Nemrac Medical and Pharma Supplies Inc.** submitted quotation for Item Nos. 1, 2, 4, 5, 7, 8, 10-14, 18, 25, 27-29, 31-36, 39, 40, 45, 46, 49, 51, 52, 79, 80, 88, 103, 104, and 136-148 in the amount of P 6,530,361.00, **Medical Center Trading Corp.** submitted quotation for Item Nos. 1, 2, 4-8, 10-14, 17, 21-29, 31, 33-40, 49-52, 79-80, 88, 93, 101-104 and 107 in the amount of P 2,941,993.20, **Scientific Biotech Specialties, Inc.** submitted quotation for Item Nos. 41-44, 53-64, 67-71, 73, 75-78, 85, 86, 94, 95, 97, 99, 100, 103, 104, 108-131 and 133-135 in the amount of P 2,826,050.00, **MedAlert Enterprises** submitted quotation for Item Nos. 1, 2, 4, 7, 8, 10, 15, 18, 27, 28, 31, 39, 46, 47, 51, 103, 104, and 143 in the amount of P 2,100,596.17, **Allied Hospital Supply International Corp.** submitted quotation for Item Nos. 7, 8, 10, 18, 32, 33, and 45 in the amount of P 1,168,300.00;

**WHEREAS**, the detailed evaluation of the bids was conducted after the opening of bids;

**WHEREAS**, in the quotation submitted by the bidders, **NO BID** was received on **Item Nos. 3, 9, 16, 19-20, 30, 48, 65-66, 72, 74, 81-84, 87, 89-92, 96, 98, 105-106, 132, and 149-151 (28 line item)** in the total amount of P 435,965.00 based on the costs stated in the Invitation to Bid;

**WHEREAS**, when the submitted bids were evaluated, **MedAlert Enterprises** submitted quotation for Item Nos. 15, and 46, 47 in the amount of P67,453.12, **Medical Center Trading Corp.** submitted quotation for Item Nos. 1, 6, 8, 11-13, 17, 21-26, 28, 34, 37-40, 50-52, 79, 88, 93, 101-104, and 107 in the amount of P910,290.00, **Allied Hospital Supply International Corp.** submitted quotation for Item Nos. 7, 10, 18, 32, 33, and 45 in the amount of P1,022,700.00, **Scientific Biotech Specialties, Inc.** submitted quotation for Item Nos. 41-44, 53-64, 67-71, 73, 75-78, 85, 86, 94, 95, 97, 99, 100, 108-131, 133-135 in the amount of P2,792,050.00, **Nemrac Medical**

136-148 in the amount of P3,819,326.00 appears to be the lowest calculated bid per item submitted of each bidder (Bid Evaluation is hereto attached for ready reference);

**NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:**

**1. TO DECLARE:**

- 1.2 **MEDICAL CENTER TRADING CORP.'s** quotation for Item Nos. 1, 6, 8, 11-13, 17, 21-26, 28, 34, 37-40, 50-52, 79, 88, 93, 101-104, and 107 in the amount of P 910,290.00;
- 1.3 **ALLIED HOSPITAL SUPPLY INTERNATIONAL CORP.'s** quotation for Item Nos. 7, 10, 18, 32, 33, and 45 in the amount of P1,022,700.00;
- 1.4 **SCIENTIFIC BIOTECH SPECIALTIES, INC.'s** quotation for Item Nos. 41-44, 53-64, 67-71, 73, 75-78, 85, 86, 94, 95, 97, 99, 100, 108-131, 133-135 in the amount of P2,792,050.00;
- 1.5 **NEMRAC MEDICAL AND PHARMA SUPPLIES CORP.'s** quotation for Item Nos. 2, 4, 5, 14, 27, 29, 31, 35, 36, 49, 80, and 136-148 in the amount of P 3,819,326.00;


as the lowest calculated and responsive bid for the supply and delivery of such laboratory supplies.


2. That **NO BID** was received for Item Nos. 3, 9, 16, 19-20, 30, 48, 65-66, 72, 74, 81-84, 87, 89-92, 96, 98, 105-106, 132, and 149-151 amounting to P 435,965.00 based on the costs stated in the Invitation to Bid, has been referred to the BAC members and thereafter decided to re-advertised and re-bid the said items, pursuant to the provisions of RA 9184.


3. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
