WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Hospital Bed and Bedside Table which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, RPHS-Angono and RPHS-Morong for the period covered 16 June 2022 to 06 July 2022, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱3,000,000.00;

WHEREAS, in response to the said advertisement, one (1) bidder/contractor purchased bid documents and submitted its bid;

WHEREAS, the bidder's technical and eligibility documents were submitted on 07 July 2022 where bidder was thereafter found to be eligible;

WHEREAS, the bid proposal of the bidder was found to be substantially complying;


NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial


