

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2023- 055
Series of 2023.**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Trophies and Medals for distribution, as per request by different barangays and schools within the Province of Rizal which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered 07 March 2023 to 27 March 2023 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Three Million Six Hundred Forty Thousand Pesos (₱3,640,000.00);

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, Gillean Trading;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 28 March 2023 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;


NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:



2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


