

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Medical Supplies for the operation of hospitals under the Rizal Provincial Hospital System which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS - Morong and RPHS - Angono for the period covered from 09 August 2023 to 29 August 2023 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is Two Million Seventy Two Thousand Five Hundred Pesos (₱2,072,500.00);

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid namely, Infinite Medical Trading;

**WHEREAS**, the bidder's technical component of the bid, including the eligibility requirements were submitted on 30 August 2023. Infinite Medical Trading was able to satisfy the requirements to participate;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**WHEREAS**, upon careful examination, validation and verification of the requirements to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted by the committee and such has been found to be responsive;

**NOW THEREFORE, WE,** the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

1. **TO DECLARE INFINITE MEDICAL TRADING** as the bidder with the single calculated and responsive bid for the Purchase of Medical Supplies for the operation of hospitals under the Rizal Provincial Hospital System in the amount of Two Million Fifty Four Thousand Three Hundred Fifty Five Pesos (P2,054,355.00);
2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
