

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF
THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING
APPROVAL****Resolution No. GS2025-046****Series of 2025.**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Monobloc Chairs for the use of Rizal Provincial Government which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 19 June 2025 to 08 July 2025 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is One Million One Hundred Thousand Pesos (₱ 1,100,000.00);

WHEREAS, in response to the said advertisement, One (1) supplier/contractor purchased bid documents and submitted its bid, that is, MNJ Trading;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 09 July 2025 and thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that MNJ Trading appears to be the single calculated bid for the Supply and Delivery of Monobloc Chairs, in the amount of One Million Ninety Five Thousand Pesos (₱ 1,095,000.00);

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** the following, and:

1. **TO DECLARE MNJ TRADING** as the bidder with the single calculated and responsive bid for the **Supply and Delivery of Monobloc Chairs** in the amount of **One Million Ninety Five Thousand Pesos (₱ 1,095,000.00)**; and,
2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.

UNANIMOUSLY APPROVED this 15th day of July 2025, at the City of Antipolo, Province of Rizal.




