

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Diploma Holder with Wooden Substrate for distribution to different schools within the Province of Rizal which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 04 February 2026 to 25 February 2026 in compliance with RA 12009, otherwise known as New Government Procurement Act and its 2025 Implementing Rules and Regulation (IRR);

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is Twenty Seven Million Eight Hundred Nineteen Thousand Ninety Pesos (₱ 27,819,090.00);

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor submitted its bid, that is, Filefix Philippines, Inc.;

**WHEREAS**, the bidder’s technical component of the bid, including the eligibility requirements were submitted on 26 February 2026 and thereafter found to be eligible;

**WHEREAS**, the bidder’s financial component of the bid was found to be substantially complying;

**WHEREAS**, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid

**NOW THEREFORE, WE**, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** the following:



2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


