

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2026-002

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of School Bags for distribution to different schools in the municipalities of San Mateo and Montalban, which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 12 December 2025 to 05 January 2026 in compliance with RA 12009, otherwise known as New Government Procurement Act and its 2025 Implementing Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Fifty Million Two Hundred Thirty Nine Thousand One Hundred Pesos (₱ 50,239,100.00);

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, MNJ Trading;

WHEREAS, the bidder's technical component of the bid, including the eligibility requirements were submitted on 06 January 2026 and thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that MNJ Trading appears to be the single calculated bid for the Supply and Delivery of School Bags in the amount of Fifty Million One Hundred Seventy Five Thousand Seven Hundred Fifty One Pesos (₱ 50,175,751.00);

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;


NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED the following:

UNANIMOUSLY APPROVED this 12th day of January 2026, at the City of Antipolo, Province of Rizal.


