

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE LOWEST CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**

**Resolution No. GS2026-025  
 Series of 2026.**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Sports Uniform for the 2026 Regional Athletic Association Meet (RAAM) Competition Proper which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 04 February 2026 to 23 February 2026 in compliance with RA 12009, otherwise known as New Government Procurement Act and its 2025 Implementing Rules and Regulation (IRR);

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is Six Million One Hundred Thirteen Thousand Six Hundred Sixty Pesos (₱ 6,113,660.00);

**WHEREAS**, in response to the said advertisement, two (2) suppliers/contractors submitted their bids, namely, MNJ Trading and Starblooms Enterprises;

**WHEREAS**, the bidders' technical component of the bid, including the eligibility requirements were submitted on 24 February 2026 and thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid were found to be substantially complying;

**WHEREAS**, when the submitted bids were read, it appears that, MNJ Trading submitted its quotation in the amount of Six Million One Hundred Three Thousand One Hundred Thirty Three Pesos (₱ 6,103,133.00), and Starblooms Enterprises submitted its quotation in the amount of Six Million Ninety Five Thousand Three Hundred Eighty Three Pesos (₱ 6,095,383.00);

**WHEREAS**, when the submitted bids were evaluated, Starblooms Enterprises' submitted its quotation for Item Nos. 1-4 and 7-21 in the amount of Four Million Five Hundred Seventy Four Thousand One Hundred Twenty Seven Pesos (₱ 4,574,127.00), and MNJ Trading submitted its quotation for Item Nos. 5 & 6 in the amount of One Million Five Hundred Eighteen Thousand Three Hundred Twenty Six Pesos (₱ 1,518,326.00) which appears to be the lowest calculated bid per item submitted of each bidder (Bid Evaluation is hereto attached for ready reference);

**WHEREAS**, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

**NOW THEREFORE, WE**, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** the following, and:

1. **TO DECLARE** as the lowest calculated and responsive bid for the Supply and Delivery of Sports Uniform for the 2026 Regional Athletic Association Meet (RAAM) Competition Proper:

1.2 **STARBLOOMS ENTERPRISES'** quotation for Item Nos. 1-4 and 7-21 in the amount of **Four Million Five Hundred Seventy Four Thousand One Hundred Twenty Seven Pesos (₱ 4,574,127.00)**;

2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
