WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Patrol Motorcycle for the Peace and Order Program of the Province of Rizal which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 31 March 2026 to 20 April 2026 in compliance with RA 12009, otherwise known as New Government Procurement Act and its 2025 Implementing Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is Eleven Million Pesos (₱ 11,000,000.00);

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors submitted its bid documents, namely, Starblooms Enterprises and K Servico Trade Inc.;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 21 April 2026;

WHEREAS, the bid proposal of Starblooms Enterprises and K Servico Trade Inc. were found to be substantially complying, subsequently, bid evaluation was conducted and resulted as follows:


NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** the following, and:



UNANIMOUSLY APPROVED this 27th day of April 2026, at the City of Antipolo, Province of Rizal.


