RESOLUTION CANCELLING THE PUBLICATION AND SUSPENDING THE PUBLIC BIDDING OF THE INFRASTRUCTURE PROJECT TITLED: "UPGRADING OF CASIMIRO A. YNARES SR. MEMORIAL HOSPITAL, MONTALBAN, RIZAL" PUBLISHED FROM 8 JANUARY TO 14 JANUARY 2024 FOR THE OPENING OF BIDS SCHEDULED ON 26 JANUARY 2024

WHEREAS, the Rizal Provincial Government advertised an Invitation to Bid for the procurement of infrastructure projects from the period of 8 January to 14 January 2024;

WHEREAS, the publication covers twenty-three (23) infrastructure projects with schedule of bid opening/public bidding on 26 January 2024;

WHEREAS, Project No. 22 in the aforementioned publication is entitled: "Upgrading of Casimiro A. Ynares Sr. Memorial Hospital, Montalban, Rizal";

WHEREAS, the fund for the said project is under the Health Facilities Enhancement Program (HFEP) of the Department of Health (DOH) for CY 2023;

WHEREAS, this 19 January 2024, Ms. Ma. Teresa E. Lasquety, Head of the Rizal Provincial Bids and Awards Committee (RPBAC) Secretariat for Civil Works and Goods received a letter from Dr. Ariel I. Valencia, OIC, Assistant Secretary of Health of the Department of Health Center for Health Development 4A(CHD4A), requesting for suspension of the bidding for the project: "Upgrading of Casimiro A. Ynares Sr. Memorial Hospital, Montalban, Rizal";

WHEREAS, the said letter cited among others, that the Scope/Program of Works, Approved Budget for the Contract. Detailed Estimate and DAED for the Provision of Fire Supresion System does not meet the Department of Health (DOH) guidelines;

WHEREAS, due to the said letter request for suspension of the bidding for the aforementioned project, it is deemed best to CANCEL THE PUBLICATION AND SUSPEND THE PUBLIC BIDDING of the infrastructure project titled: "Upgrading of Casimiro A. Ynares Sr. Memorial Hospital, Montalban, Rizal" published on 8 January to 14 January 2024 for the Opening of Bids scheduled on 26 January 2024;

WHEREAS, considering the said letter request for suspension of the bidding for the aforementioned project, the RPBAC decided to CANCEL THE PUBLICATION AND SUSPEND THE PUBLIC BIDDING of the infrastructure project titled: "Upgrading of Casimiro A. Ynares Sr. Memorial Hospital, Montalban, Rizal" published on 8 January to 14 January 2024 for the Opening of Bids scheduled on 26 January 2024
