WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Laboratory Supplies which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Rizal Provincial Hospital-Morong Main and Ynares Sports Arena for the period covered 19 April 2021 to 10 May 2021 in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P3,551,850.00;

WHEREAS, in response to the said advertisement, three (3) suppliers/contractors purchased bid documents and submitted its bid;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 11 May 2021 and thereafter found to be eligible;

WHEREAS, the other bidder's financial component of the bid was found to be substantially complying;

WHEREAS, when the submitted bids were read, it appears that **Allied Hospital Supply International Corporation** submitted quotation for Item Nos. 13 and 14 in the amount of P312,000.00, **Scientific Biotech Specialties, Inc.** submitted quotation for Item Nos. 32, 33, 36-44, 48, 49 and 52-81 in the amount of P1,287,328.00 and, **Medical Center Trading Corp.** submitted quotation for Item Nos. 1-7, 9-11, 15-22, 24-33, 31-33 and 54 in the amount of P 2,814,578.00;

WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, in the quotation submitted by the bidders, **no bid** was received on Item Nos. 8, 12, 23, 34, 35, 45, 46, 47, 50 and 51 (10 line item) in the total amount of P 24,250.00;

WHEREAS, when the submitted bids were evaluated, **Allied Hospital Supply International Corporation's** quotation for Item Nos. 13 and 14 in the amount of **P312,000.00**, **Medical Center Trading Corp.'s** quotation for Item Nos. 1-7, 9-11, 15-22, 24-30, 31 and 54 in the amount of **P 1,232,192.00**, **Scientific Biotech Specialties, Inc.** quotation for Item Nos. 32, 33, 36-44, 48, 49, 52, 53, and 55-81 in the amount of **P 1,277,728.00**; and appears to be the lowest calculated bid per item submitted of each bidder (Bid Evaluation is hereto attached for ready reference);

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** the following, and:

1. TO DECLARE:

- 1.1 **ALLIED HOSPITAL SUPPLY INTERNATIONAL CORPORATION's** quotation for Item Nos. 13 and 14 in the amount of **P312,000.00**;


- 1.2 **MEDICAL CENTER TRADING CORP.'s** quotation for Item Nos. 1-7, 9-11, 15-22, 24-30, 31 and 54 in the amount of **₱ 1,232,192.00;**
- 1.3 **SCIENTIFIC BIOTECH SPECIALTIES, INC.'s** quotation for Item Nos. 32, 33, 36-44, 48, 49, 52, 53 and 55-81 in the amount of **1,277,728.00;**

as the lowest calculated and responsive bid for the supply and delivery of such laboratory supplies.


