**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the provision of detainee's subsistence which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol Building, Ynares Sports Center and Ynares Sports Arena for the period covered 02 December 2021 to 21 December 2021, in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is P1,500,000.00 or P 60.00 per head/day;

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid;

**WHEREAS**, the bidder's technical component of the bid, including the eligibility requirements were submitted on 22 December 2021 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;
