

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2021- 042
Series of 2021**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Trash Bin which was posted in the Philippine Government Electronic Procurement System (PhilGEPs) and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Rizal Provincial Hospital-Morong Main and Ynares Sports Center for the period covered 7 May 2021 to 26 May 2021, in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P 1,178,575.00;

WHEREAS, in response to the said advertisement, two (2) contractors/suppliers purchased bid documents and submitted its bid;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 27 May 2021 and was thereafter found out that only one (1) bidder that is JSG Polymax Industrial Corporation complied with the requirements;

WHEREAS, INCA Philippines, Inc. having been failed to submit the 2019 Income Tax Return (ITR) and Financial Statement (FS), was declared Disqualified to participate in the bidding;

WHEREAS, the bid proposal of the bidder was found to be substantially complying;

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposals, it was found out that JSG Polymax Industrial Corporation appears to be the single calculated bid for the purchase of Trash Bin in the amount of P 1,037,440.00;


WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, all of the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

1. **TO DECLARE JSG POLYMAX INDUSTRIAL CORPORATION** as the bidder with the single calculated and responsive bid for the supply and delivery of Trash Bin in the amount of **₱1,037,440.00**; and
2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
