**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Medical Oxygen (Refill) which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Ynares Center Complex and Ynares Sports Arena for the period covered 06 December 2021 to 27 December 2021 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR, for brevity);

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is P 11,970,000.00;

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid;

**WHEREAS**, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 27 December 2021 and where bidder was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**NOW THEREFORE, WE**, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


