**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Global Positioning System (GPS), Global Navigation Satellite System – Real Time Kinetic (GNSS – RTK) & Notebook Computer which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Ynares Center Complex and Ynares Sports Arena for the period covered 28 January 2022 to 16 February 2022 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is P 1,590,000.00;

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid;

**WHEREAS**, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 17 February 2022 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
