WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, when the submitted bids were evaluated, Medical Center Trading Corporation submitted quotation for Item Nos. 5 in the amount of \$\mathbb{P}798,900.00\$, Nemrac Medical & Pharma Supplies Corp. submitted quotation for Item Nos. 4 and 7 in the amount of \$\mathbb{P}1,280,000.00\$, JCOR Medical Equipment and Supplies Trading submitted quotation for Item Nos. 2, 3 and 8 in the amount of \$\mathbb{P}1,950,000.00\$, Infinite Medical Trading submitted quotation for Item Nos. 6 in the amount of \$\mathbb{P}2,350,000.00\$, and Robustan Inc. submitted quotation for Item Nos. 1 in the amount of \$\mathbb{P}3,520,000.00\$.
