WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 30 August 2022 and thereafter found to be eligible;

WHEREAS, the other bidder's financial component of the bid was found to be substantially complying;

WHEREAS, when the submitted bids were read, it appears that, Infinite Medical Trading submitted quotation for Item Nos.1-6 in the amount of ₱ 2,564,920.00 and Bio-Fil Pharma Marketing Corporation submitted quotation for Item Nos. 1-6 in the bid amount of ₱ 2,563,995.00

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid;

WHEREAS, when the submitted bids were evaluated, Bio-Fil Pharma Marketing Corporation submitted quotation for Item Nos. 1-3 and 5 in the amount of ₱ 1,235,835.00 and Infinite Medical Trading submitted quotation for Item Nos. 4 and 6 in the amount of ₱1,313,640.00.

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED the following, and:

1. TO DECLARE:
