

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE LOWEST CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2023-102
Series of 2023.**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of One Hundred Fifty (150) units of Motorcycle with Cargo Type Sidecar for distribution to different barangays within the Province of Rizal, in line with the YES to Green Program which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Building, RPHS – Angono and RPHS - Morong for the period covered 28 July 2023 to 15 August 2023 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Twenty Three Million Two Hundred Fifty Thousand Pesos (₱23,250,000.00);

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid, namely: MCX International, Inc and K Servico Trade, Inc.;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 16 August 2023 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that K Servico Trade, Inc. appears to be the lowest calculated bid for the Purchase of One Hundred Fifty (150) units of Motorcycle with Cargo Type Sidecar in the amount of Twenty Two Million Five Hundred Thousand Pesos (₱22,500,000.00);

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

1. **TO DECLARE K SERVICIO TRADE, INC.** as the bidder with the lowest calculated and responsive bid for the Purchase of One Hundred Fifty (150) units of Motorcycle with Cargo Type Sidecar in the amount of Twenty Two Million Five Hundred Thousand Pesos (₱22,500,000.00);
2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
