

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF  
THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING  
APPROVAL****Resolution No. GS2023-017****Series of 2023.**

**WHEREAS**, the Rizal Provincial Government re-advertised the Invitation to Bid for the Supply of Fuel through Fleet Card Facility for the Service Vehicles of the Rizal Provincial Government which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol Building, RPHS – Morong and RPHS - Angono for the period covered 12 January 2023 to 31 January 2023 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, under Bids and Awards Committee (BAC) Resolution No. GS2022-127 Series 2022, the Rizal Provincial Government previously conducted a procurement activity for the above-named project. However, the BAC declared a failure of bidding as no prospective bidders submitted the required documents on the first invitation/advertisement. Thus the procurement activity for the same project was posted and advertised for a second time;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the second Invitation to Bid is ₱25,760,000.00;

**WHEREAS**, in response to the second advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, Petron Corporation;

**WHEREAS**, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 01 February 2023 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**WHEREAS**, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

**WHEREAS**, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Petron Corporation appears to be the single calculated bid for the Supply of Fuel through Fleet Card Facility in the amount of ₱25,759,000.00;

**WHEREAS**, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

**NOW THEREFORE, WE,** the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:



2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


