

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**

**Resolution No. GS2024- 148  
Series of 2024.**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Provision of Balanced and Nutritious Daily Meals for Rizal Provincial Hospital System Patients which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 26 November 2024 to 15 December 2024 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR);

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is Twenty Nine Million Four Hundred Ninety Nine Thousand Eight Hundred Forty Pesos (₱ 29,499,840.00) or One Hundred Eighty (₱ 180.00) per head/day;

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, EDCT Food Services;

**WHEREAS**, the bidder’s technical component of the proposal, including the eligibility requirements were submitted on 16 December 2024 and was thereafter found to be eligible;

**WHEREAS**, the bidder’s financial component of the bid was found to be substantially complying;

**WHEREAS**, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

**WHEREAS**, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that EDCT Food Services appears to be the single calculated and responsive bid for the Provision of Balanced and Nutritious Daily Meals in the amount of One Hundred Seventy Five Pesos (₱ 175.00) per head/day;

**WHEREAS**, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid



**NOW THEREFORE**, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

1. **TO DECLARE EDCT FOOD SERVICES** as the bidder with the single calculated and responsive bid for the **Provision of Balanced and Nutritious Daily Meals** in the amount of **One Hundred Seventy Five Pesos (₱ 175.00) per head/day**;
2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


