

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL****Resolution No. GS2024 - 033  
Series of 2024.**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Food Commodities and Sacks for relief assistance intended to disaster-stricken families/individuals which was posted in the Philippine Government Electronic Procurement System (PhilGEPs), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Angono and RPHS - Morong for the period covered 01 February 2024 to 20 February 2024 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is Two Million Nine Hundred Sixty Four Thousand Eight Hundred Twenty Three Pesos (₱ 2,964,823.00);

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, Green Energy Trading;

**WHEREAS**, the bidder's technical component of the bid, including the eligibility requirements were submitted on 21 February 2024 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**WHEREAS**, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

**WHEREAS**, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Green Energy Trading appears to be the single calculated and responsive bid for the Purchase of Food Commodities and Sacks in the amount of Two Million Eight Hundred Fifty Five Thousand Nine Hundred Fifty Eight Pesos (₱ 2,855,958.00);


**WHEREAS**, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the bidder's bid is found to be responsive and compliant with the requirements of RA 9184 and its IRR.


**NOW THEREFORE, WE,** the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


1. **TO DECLARE GREEN ENERGY TRADING** as the bidder with the single calculated and responsive bid for the Purchase of Food Commodities and Sacks in the amount of Two Million Eight Hundred Fifty Five Thousand Nine Hundred Fifty Eight Pesos (₱ 2,855,958.00);
2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


**UNANIMOUSLY APPROVED** this 27<sup>th</sup> day of February 2024, at the City of Antipolo, Province of Rizal.


