

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

Resolution No. GS2024 - 147

Series of 2024.

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of IV Fluids for use of hospitals under Rizal Provincial Hospital System (RPHS) which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Angono and RPHS - Morong for the period covered 22 November 2024 to 12 December 2024 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Twenty Nine Million Pesos (₱ 29,000,000.00);

WHEREAS, in response to the said advertisement, one (1) supplier purchased bid documents and submitted its bid, that is: Nemrac Medical and Pharma Supplies, Corp.;

WHEREAS, the bidders’ technical component of the bid, including the eligibility requirements were submitted on 13 December 2024 and thereafter found to be eligible;

WHEREAS, the bid proposal of Nemrac Medical and Pharma Supplies, Corp. was found to be substantially complying, subsequently, bid evaluation was conducted and resulted as follows:


NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.




