

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**

**Resolution No. GS2025 - 013  
Series of 2025.**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Sporting Goods and Equipment for 2025 Regional Athletic Association Meet (RAAM) Competition Proper which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Angono and RPHS - Morong for the period covered 28 January 2025 to 16 February 2025 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is Five Million One Hundred Fifty One Thousand Three Hundred Twenty Two Pesos (₱ 5,151,322.00);

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, MNJ Trading;

**WHEREAS**, the bidder’s technical component of the bid, including the eligibility requirements were submitted on 17 February 2025 and was thereafter found to be eligible;

**WHEREAS**, the bidder’s financial component of the bid was found to be substantially complying;

**WHEREAS**, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

**WHEREAS**, in the Bill of Quantities submitted by the MNJ Trading, **no bid** was received on **Item Nos. 21, 30, 42 and 60** (4 line item) in the total amount of ₱ 246,000.00;

**WHEREAS**, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that MNJ Trading appears to be the single calculated and responsive bid for the Purchase of Sporting Goods and Equipment in the amount of Four Million Eight Hundred Ninety Five Thousand Six Hundred Sixty Two Pesos (₱ 4,895,662.00);

**WHEREAS**, upon careful examination, validation and verification of the requirements, to the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;


**NOW THEREFORE**, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

1. **TO DECLARE MNJ TRADING** as the bidder with the single calculated and responsive bid for the **Purchase of Sporting Goods and Equipment** in the amount of **Four Million Eight Hundred Ninety Five Thousand Six Hundred Sixty Two Pesos (₱ 4,895,662.00)**;
2. That **NO BID** was received for Item Nos. 21, 30, 42 and 60 (4 line items) amounting to ₱ 246,000.00 has been referred to the BAC members and thereafter decided to cancel the said items, pursuant to the provisions of RA 9184.
3. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.




