WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Supplies for use in Peritoneal Dialysis at Rizal Provincial Hospital System–Margarito A. Duavit Memorial Hospital (RPHS-MADMH) which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS - Morong and RPHS - Angono for the period covered from 27 December 2024 to 15 January 2025 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Nineteen Million Seven Hundred Twenty Six Thousand Six Hundred Pesos (₱ 19,726,600.00);

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, Sta. Ana Healthcare Plus Corporation;

WHEREAS, the bidder's technical component of the bid, including the eligibility requirements were submitted on 16 January 2025. Sta. Ana Healthcare Plus Corporation was able to satisfy the requirements to participate;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:



UNANIMOUSLY APPROVED this 21st day of January 2025, at the City of Antipolo, Province of Rizal.




