

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**Resolution No. GS2025-022

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Twenty (20) units Passenger Van for distribution to different agencies within the Province of Rizal with approved DILG Authority to Purchase Motor Vehicle (POV CN 2025-031) which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong, RPHS- Angono for the period covered 21 February 2025 to 12 March 2025 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Twenty Five Million Eight Hundred Thousand Pesos (₱ 25,800,000.00);

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, Toyota Commonwealth, Inc.;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 13 March 2025 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Toyota Commonwealth, Inc. appears to be the single calculated bid for the Supply and Delivery of twenty (20) units Passenger Van in the amount of Twenty Three Million Five Hundred Thirteen Thousand Pesos (₱ 23,513,000.00);

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


1. **TO DECLARE TOYOTA COMMONWEALTH, INC.**, as the bidder with the single calculated and responsive bid for the **Supply and Delivery of Twenty (20) units Passenger Van** in the amount of **Twenty Three Million Five Hundred Thirteen Thousand Pesos (₱ 23,513,000.00)**;
2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.






